


THE NEW BURGO ENERGIA WEBSITE IS ONLINE

Burgo Energia is a wholly owned subsidiary of Burgo Group and a recognised active player in the main energy markets, specialising in the optimisation of energy management. From 27 July, burgoenergia.it website is online with a completely renewed look and services.

Burgo Energia offers Demand-Response services such as management of the Capacity Market, the interruptible electricity and gas loads, the energy portfolio of electricity and gas, and the ETS/EUA allowances. Specific services for the energy market can now be attained through an agile and dynamic website, which is easy to navigate and complete with information.





Burgo Energia has several energy savings projects underway that contribute to obtaining multiple white certificates. The reduction of industrial consumption is key to reducing the need for gas, consequently reducing CO2 emissions and at the same time containing energy expenses.

Burgo Energia is completing the activities to implement the ISO 50001 certification for five paper mills of Mosaico S.p.A., while Burgo plants are already certified. Soon, the Burgo Ardennes SA plant in Belgium will also be certified; a plant which, thanks to the large usage of biomass, aims to become the Group's first Net-Zero-Emission plant within a few years.



Luca Sassoli, CEO of Burgo Energia, highlights the importance of the Burgo Group's actions:

"Burgo Group's decarbonisation objectives are ambitious: achieving a 55% reduction in emissions by 2030, as envisaged by the European Green Deal, is a demanding challenge. Burgo Energia assists the Group with these endeavours as well as with renewable sources, with large-scale projects on photovoltaic and other sources of energy such as hydroelectricity, biomass, and bio-methane. The road to decarbonisation runs through several routes, and Burgo Energia is equipped to pursue them all."



The new website shows the numbers that empower the company: over 70 GWh of energy purchased from the power grid, over 400 GWh of energy fed into it, 270 MW of interruptible power managed through the Energy Paper Consortium, and over 1 million cubic metres of gas delivered for the gas interruptible load service.

The recent release of burgoenergia.it reveals the new positioning and the new visual identity of Burgo Energia, developed by Ars Media, a communication agency based in Turin which for years has been a partner of Burgo Group and Mosaico, and has taken care of the design and development of the new website. The activities were coordinated by Patrizio Viero, the company's Marketing & Communication manager:

Burgo Energia offers Demand-Response services such as management of the Capacity Market, management of the interruptible electricity and gas loads, management of the energy portfolio of electricity and gas, and the ETS/EUA allowances. Burgo Energia currently manages the energy produced in 11 plants, handling the dispatch of electricity and the participation in the MSD Market, the related electricity supply, the Asset Optimization of power plants, the Capacity Market, and all Demand Response services that can be utilized at present.
